Context

Starting Jan 4, 2010, all bulk & break-bulk shipment arriving in the Philippines are subject to the provisions of Administrative Order No 243-A and its Implementing Rules and Regulations.

AO 243-A and its IRR provides that all bulk a break bulk cargoes must be covered by report of a cargo surveying company accredited by the Committee for Accreditation of Cargo Surveying Companies (CACSC) to facilitate the release of the cargoes from the Bureau of Customs BOC).

This procedure facilitates the proper examination, of bulk and break bulk cargoes using measures compliant with customs international best practices and global trade standards.

The report is issued by the accredited cargo surveying company after a full survey of the quantity, quality, and grade-of the bulk or breakbulk cargo.

Bureau Veritas was accredited by CACSC on December 2009.

The accreditation was renewed on December 2015.
