The Resolution No. 96 of the year 2015 issued by the Central Bank of Libya on 30th April 2015 lays down the obligation to present a **Certificate of Inspection for all goods imported into Libya** as a condition to open a documentary Letter of Credit.

- ✓ Verification that goods presented match the description in the import documents
- ✓ Checking of goods against the list of banned goods
- ✓ Issuance of the certificate of inspection secured with an hologram for validation of the documentary L/C
