Nevertheless, Bureau Veritas may also invoice the Seller in the event of supplementary inspection visits (aborted or unsatisfactory results during first Inspection). The costs incurred by the Seller in presenting the goods for inspection, such as unpacking, handling, testing, sampling, repackaging... are for the Seller's account.*

- *For all items the proposed fees are based on F.O.B. value of the consignment*
- *Fees applicable to the Programme will be paid per inspection. They are set to cover the cost of inspection of the consignment including sampling when necessary, the documentary review and the conformity certificates (if satisfactory).*

*Does not include any additional work that may be required, such as shipping & testing of samples.*

- *For all items the proposed fees are based on F.O.B. value of the consignment, in case FOB value is not provided 10% shall be added on the final invoice EXW (Ex-Works) amount.*
