**BAN OF INDIAN HEMP AND ITS RESIN (OR EXTRACTS) AS INGREDIENT IN PRODUCTS: 15-11-2021**

Following KEBS instruction letter (KEBS/OP/10/01/VOL. 141 (08)) issued on 15-11-2021, India hemp is classified as a narcotic drug under Narcotic Drugs and Psychotropic Substances (control) Act. A list of narcotic and psychotropic substances (as defined under Section 2 of this Act) are given in the First and Second schedule respectively. This includes Indian hemp as well as its resin (or extracts). From the definition given in the Act, any substance specified in the first or second schedule or anything that contains any substance specified in those schedules is prohibited unless imported by a licensed person as provided for under Section 16 of the Act.

**BAN OF PLASTIC CARRIER BAGS AND FLAT BAGS USED FOR COMMERCIAL AND HOUSEHOLD PACKAGING: 23-10-2017**

Following the directive issued by the Kenyan National Environmental Management Authority (NEMA), the plastic carrier bags and flat bags (sold as a product) are banned from import to Kenya from 28th August 2017.

Plastic carrier bag: Any bag regardless of its thickness and color, used at the supermarkets, retail stores, shopping malls and grocery stores as secondary packaging.

Flat bag: A plastic bag constructed without handles which may have a gusset.

However, the ban does not apply to bags / plastic foils used to wrap products during industrial packaging.

**BAN OF USED LUBRICATING OIL, USED LUBRICANTS AND USED BASED OILS: 08-06-2018**

It has come to our notice that used lubricating oil is being recycled and packaged as engine oil or imported as virgin base oils by unscrupulous traders. To curb the menace, all lubricants and base oils imports shall be tested at source by the PVOC Agents under Route A to determine compliance with the requirements of Kenya Standards or approved specifications before the issuance of Certificate of Conformity (COC) for such consignments. Please take note that importation of recycled base oils shall not be allowed into Kenya.

**BAN OF EGGS AND EGG DERIVATIVE/RELATED PRODUCTS FROM CHINA AND PROXIMITY TERRITORIES - Posted on KEBS website on: 16-06-2010**

Following the reports of detection of contamination of eggs with melamine in China, Kenya Bureau of Standards has imposed a ban on the importation of eggs and other eggs related products from China and proximity territories with immediate effect. The related eggs products will include noodles, mayonnaise, animal feeds and animal feed inputs.

This is in addition to the earlier announcement on the ban on milk and milk related products and strict surveillance on all food and foodstuffs from China and related countries.

This exercise will be in force until the affected products are proved to be free from the contaminants.

**BAN OF MILK AND MILK RELATED PRODUCTS FROM CHINA AND PROXIMITY TERRITORIES - Posted on KEBS website on: 22-09-2010**

Following a global alarm of milk and milk related products and foods from the People's Republic of China and proximity territories, Kenya Bureau of Standards announces the following measures aimed at protecting the health and safety of Kenyans to take effect immediately:

All milk and milk related products from China and proximity territories have been banned from entering Kenya until further notice and review.

- All foodstuffs from China and proximity territories shall undergo 100% inspection in Kenya and the countries of origin before shipping.
- Foodstuffs and related products already in the Kenyan market outlets from China and proximity territories shall undergo surveillance to establish health and safety for our nationals and visitors.

**BAN ON THE IMPORTATION AND SALE OF SUB-STANDARD DRY CELL BATTERIES - Posted on KEBS website on: 17-06-2009**

A Kenya Bureau of Standards market surveillance team has established that substandard dry cell batteries are still on sale despite earlier Public Notices.

Consumers are advised to look for the Diamond Mark of Quality before making their purchases to ensure the safety of electronic equipment and a worthwhile quality purchase. If you come across these batteries in any retail outlet please report to the nearest Kenya Bureau of Standards office or seek the assistance of any law enforcement agency. **Diamond Mark of Quality Symbol of Product Quality Excellence.**

#### BANNED COSMETICS - Posted on KEBS website on: 21-04-2009

The prohibition/ban is aimed at protecting unsuspecting consumers and discourages dumping of these products in the Kenyan Market. Hydroquinone, oxidizing agents and hormonal preparations are used for treating various medical conditions. They are therefore classified as drugs and should be applied only upon the advice and direction of a medical doctor.

All skin care preparations like creams, lotions, gels, soaps, etc containing hydroquinone, steroids and hormonal preparations should be registered by the Pharmacy and Poisons Board of the Ministry of Health for medical use. Their use in cosmetics was prohibited through gazette notices 4310 of 14th August 1998 and 7169 of November 2000.

The Government wishes to state that the following products are registered with Pharmacy and Poisons Board to be used as human medicines for various skin conditions:

BETNOVATE, MEDIVEN, DIPROSONE, NERISONE, DERMOVATE, HYDROCORTISONE, OXY 5 AND OXY 10.

These products should only be used on the recommendation of a medical doctor and for such period of time as the doctor may prescribe. They should not be sold in the open market but only in registered pharmacies and chemists. Cosmetic products listed below contain hydroquinone, steroids, mercury and hydrogen peroxide. They have not been registered with Pharmacy and Poisons Board as medicines. They therefore, should NOT
